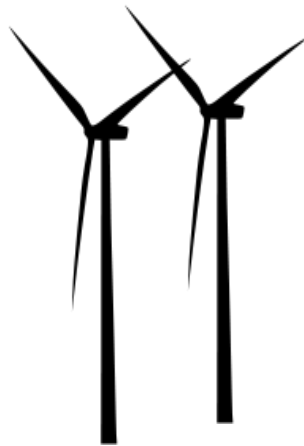
Important Information

A Message from the Police Chief

We are definitely under some trying times again. Instead of dealing with a weather related emergency, we are now facing an epidemic that is affecting the entire world it seems. Just like the tornado that came through almost two years ago, we are going to have to come together as a community and watch out for each other. As Police Chief, I reach out to all of you to do your part and also to help each other out as needed. Please follow the recommendations that are coming out of the Sheboygan County Public Health Division. They are putting out a daily update just before 3 PM on a regular basis. You can find this updates on the Sheboygan County website (www.sheboygancounty.com). There is a link on the first page to the Coronavirus (COVID-19) page. I am also involved in the Emergency Operations Center (EOC) that is running and know that we are trying to do everything we can to try and get back to some degree of stability as a community.

As COVID-19 is ever changing, it is putting a strain on everyone. As a result of some of the recommendations, the Cascade Police Department is changing how it responds to calls for service. Depending on the call type, we may chose to handle a call over the phone instead of in person. We may also ask that complainants meet us outside and conduct contacts outside. We are trying to limit our unnecessary exposures on non-emergent calls. This is pretty much the response that is being incorporated by the law enforcement community around the county.

If you call in to the Sheboygan County Dispatch Center for emergency call or one requiring a response by First Responders and Ambulances, do not be alarmed when the dispatcher starts asking screening questions for the COVID-19 virus. Please provide honest answers, so proper information can be given to the responders and proper precautions can be taken.

As a reminder the Sheboygan County Mass Notification system is in place, CodeRed. There will be a test of the system on Thursday March 26, 2020. There is a link on the COVID-19 page of the county website to sign up for the Code Red Notifications. More information on CodeRed is also available on the page.

Please take care of your families and yourself during these trying times. Please follow recommendations that are being expressed, to include hand-washing and social distancing. In the end it is everyone's responsibility to make sure we are doing our part to limit the spread of the virus.
